# **1 - APPROVAL OF MINUTES**

Minutes from the last School Council meeting (03-15-23) were approved unanimously.

#### 2 - SCHOOL IMPROVEMENT GOAL #2 (COMMUNITY SERVICE)

Discussion included the following points:

- The draft of the <u>policy language</u> developed by the subcommittee remains available for the Council's review.
- KS will continue work on the website (inspired by the Concord-Carlisle model) and seek to complete it before our next meeting.
- We expect a "soft launch" next year that would include opening of the website to all students. If we win School Committee approval for the new graduation requirement, it would take effect for members of the Class of 2028 (currently in 7th grade) when they enter HHS.
- We hope that a "program administrator" (i.e., somebody to track hours, review reflections, etc.) with a stipend of approximately \$5000 per year could be added to the regular school budget, beginning in FY25.
- We will aim to bring a proposal to the School Committee at its August meeting.
- MA will seek legal counsel regarding issues of school liability.

## 3 - SCHOOL IMPROVEMENT GOAL #5 (SCHOOL CULTURE & "SENSE OF BELONGING")

RS and JL summarized Unity Week and Council members provided feedback. Key points:

- GG suggested that the formal aspect of the "Snowball" dance might have damaged its popularity.
- DD recommended linking the Open Mic Night (Monday) with the OrigiNation dance performance (Thursday), perhaps inviting top performers back to reprise their acts later in the week.
- KS recommended more active recruiting for the evening events.

- PS recommended that we directly involve the dance team with the OrigiNation event.
- JR observed that "change is hard" in our community and urged the Unity Project to persevere in its efforts.

#### 4 - SCHOOL IMPROVEMENT GOAL #4 (ENVIRONMENTAL STEWARDSHIP)

RS described events of the ongoing Green Week. Several members called for better promotion and JR noted the potential utility of video screens in the lobby and/or school cafeteria. However, the ban on single-use plastic water bottles at Town Meeting delivered a significant Green Week highlight.
