1 - APPROVAL OF MINUTES

Minutes from the last School Council meeting (01-18-23) were approved unanimously.

2 - SCHOOL IMPROVEMENT GOAL #2 (COMMUNITY SERVICE)

- On behalf of the Hingham Student Advisory Committee (SAC), Alex Doggett and Nathan Tesler delivered a presentation relative to the implementation of a new community service requirement for HHS students.
- The SAC aimed to answer three guiding questions: 1) What should the requirement be? 2) Where will the hours be tracked? and 3) Who will oversee the program?
- For purposes of comparison, the SAC examined the Program of Studies and graduation requirements of benchmark districts. The SAC also made direct personal contact with eight local school districts in order to enhance their research.
- AD and NT shared the data collected from other school districts.
- The SAC proposes that HHS should:
 - require all students to complete 40 hours of total service (i.e., 10 service hours per year) as a new graduation requirement;
 - allow students to begin collecting service hours during the summer prior to 9th grade;
 - prorate the requirement for students who enter HHS after the 9th grade; and
 - anticipate and plan for potential challenges, including the reporting of false or inappropriate hours, lack of completion, etc.
- School Council members were especially impressed with the website developed at Concord-Carlisle High School and hope to develop a similar site for HHS.
- Members voiced concerns about adding responsibilities to building administrators, especially in light of looming HPS budget cuts.

- Members agreed that in-school community service could include peer tutoring, aiding in the RISE classrooms, Best Buddies, etc.
- J. Lee volunteered to chair a subcommittee that will draft language for possible inclusion in the HHS Student Handbook and Program of Studies.
