#### **Remote meeting via Zoom**

## 1. Call to Order

Once appointed, the search committee will meet to discuss the resumes and decide who will be called in for an interview. The interviews will be held in public. After the interviews, the School Committee will meet to vote on the candidate to be appointed as interim superintendent.

Liza recommended calling the hiring committee a "screening committee" as it would allow the members to go into executive session to consider the applicants, draft questions, perform due diligence to pull helpful information.

### 3. To appoint an interim superintendent search committee and act as appropriate
