# **Massachusetts DESE Grant: World Languages**

Dr. Adams reported that the Hingham Public Schools was successful in its application for a grant from DESE to support of proficiency-based outcomes in languages

other than English. The intended outcomes of the grant are for districts improve programs by supporting world language faculty to access the World Languages Framework Implementation Series, and for districts to provide appropriate time and environment to engage in ongoing collaboration toward aligning or developing district curriculum to align to the 2021 Massachusetts World Languages Curriculum Framework. Hingham Public Schools has been awarded \$9,375 to meet these goals.

# Mass Cultural Council FY23 STARS Residency Grant Award

Dr. Adams reported that the Hingham Public Schools was successful in its application for a visiting artist grant offered by the Mass Cultural Council through its STARS Residency Grant Proposal Program totaling \$3,250. Hingham's grant award will be used to facilitate a five-day workshop series with a visiting artist. This workshop will be run at Hingham High and will impact 58 students across grades 10-12.

# **Cape Cod Bank 5 Educational Mini-Grants**

Dr. Adams reported that the Hingham Public Schools was successful in its application for two Cape Cod 5 Educational Mini-Grants from Cape Cod Bank. Hingham Public Schools was awarded grant funding totaling \$769.00. The first Hingham grant award, in the amount of \$280.00, will be used to purchase an additional spectrophotometer for Hingham High School's Science Department. The second grant, in the amount of \$489.00, was awarded to Hingham, in order to fund the Endangered Turtle Project at Hingham Middle School.

## **DESE OAPL WPI Storyline Professional Development Initiative**

Dr. Adams reported that the Hingham Public Schools was successful in its application for funding from the DESE OAPL initiative which provides reimbursement to districts for substitute-related expenses in support of science professional development. Massachusetts educators can enroll in these courses for free and the district will also receive teacher substitute reimbursement upon completing the course. At the completion of the OAPL course, Hingham Public Schools will be awarded a substitute stipend totaling \$6,000.00.

#### **DESE Genocide Education Grant**

Dr. Adams reported that the Hingham Public Schools was successful in its application for a grant offered by the Massachusetts Department of Elementary and Secondary Education (DESE). The Genocide Education Grant is meant to support the teaching of the history of genocide, as per Chapter 98 of the Acts of 2021, which states, "Every school district shall, for the purpose of educating middle and high school students, provide instruction on the history of genocide consistent with the content standards articulated in the history and social science curriculum framework." Hingham Public Schools was awarded grant funding totaling \$6,100.

# Proposed changes to MOU on comfort dog at HHS

The Committee asked questions about Officer Ford's schedule as the dog's handler.

Jen Benham explained that the Policy Subcommittee also met with Dr. Adams and reviewed the Memorandum of Understanding on comfort dogs. The Policy Subcommittee had two proposed two changes to the document.

# Proposed changes to IHGB-Homeschooling Policy (first read)

Chair of the Policy Subcommittee Jen Benham stated that the changes are to clear up some discrepancies in the policy so it is clear that the Superintendent is authorized to approve home school applications. Tim Dempsey asked that the School Committee receive regular updates of home school numbers as part of the monthly enrollment update.
