MEETING MINUTES

Called to Order at 7 :00 PM

School Committee Chair Nes Correnti called the meeting to order at 7:00 PM, and began by reading the following statement for those participating by zoom:

She explained that the project was created by High School Student Max Bohane who was present and spoke about how he came up with the idea for the project and how it has had a positive impact on him. There were several students from Plymouth River Elementary present who described their experience with the project.

School Showcase: Hingham Middle School

Middle School Principal Derek Smith and Middle School Teacher Jennifer Driscoll gave a presentation detailing the class of 2027 Civics Projects which detailed topics that the students have been learning to advocate for by participating in local and state government.
